Take Rt. 676 South to Rt. 42 South. Follow directions from the Walt Whitman Bridge.

From Walt Whitman Bridge or Washington Township via the Black Horse Pike (42):

Take the Walt Whitman Bridge to Rt. 42 South until you reach Geets Diner. Continue east & follow signs for Rt. 322 East-Blackhorse Pike. Geets Diner is on the left. Go 3 lights past Geets Diner. Make right onto Corkery Ln.. Super Wawa is on right. Go 1 mile to light at Blue Bell Rd. Go through light and go 200 feet to Sykesville Rd. Turn left onto Sykesville Rd. and follow 1 mile until you reach camp.

From Cherry Hill/Marlton:

Follow Rt. 295 South to Rt. 42 South. Follow directions from the Walt Whitman Bridge.

or

Follow Rt. 73 South through the Berlin Circle. Exit Rt. 73 at 536 Spur - Williamstown/Glassboro. Follow approx. 8 miles until you reach Rt. 322-Black Horse Pk. Turn left onto Rt. 322 East. Geets Diner is on the right. Go 3 lights past Geets and make right onto Corkery Ln. Super Wawa is on right. Go 1 mile to light at Blue Bell Rd. Go through light and go 200 feet to Sykesville Rd. Turn left onto Sykesville Rd. Follow 1 mile until you reach camp.

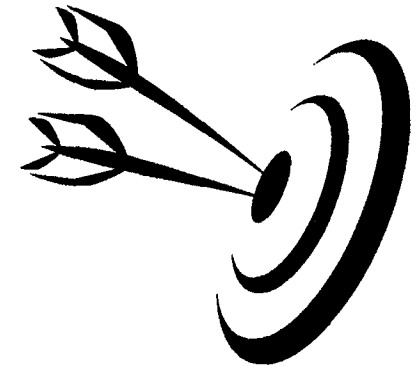
From the Atlantic City Area:

Instructions

To enroll yourself, or a staff member, please read the fine
print, then mail this completed for along with a check for the
full amount, payable to Tall Pines Day Camp.

The Fine Print: Space in the course is limited and subject
to first come, first served. If minimum number is not met, we
reserve the right to cancel the course on or before 5/15/10
and refund money. We expect participants in good health,
with a recent physical, and prepared for rigors of a
concentrated course.

Cancellation: if you cancel for any reason, a full refund will
be made if notice reaches us in **writing** by 5/15/10. After
that substitutions may be freely made, but no refund will be
issued. Camp Directors, be sure your staff person knows
this! Upon receipt of registration, a confirmation,
instructions and directions will be mailed. Mere participation
does not guarantee a student will pass! On time arrival and
attendance for the full period is required. Photo copy the
form if you need more. For the ACA rate, you must supply
your membership or camp number. Participants must
complete standard health history and sign an ACA liability
waiver. Health history is available in the Staff Section of our
web site – www.tallpinesdaycamp.com Alcohol and illegal
substances are prohibited and participants will be sent home
without a refund. It is permitted to enroll a "tentative"
candidate now to hold space if you know your camp will
need someone trained. You may cancel up until May 15, but
more importantly, you may substitute and change candidates
right up to 2 days before the course – just tell the office
about the change!

Late Fee: There is a \$20.00 late handling fee on all
enrollments accepted after May 15, 2010.

Add \$10.00 if not an ACA Member Camp. Full payment
must accompany enrollments.
